WHEREAS the institution namely National College of Education, Keelakollai, Maungor Post, Kumbakonam Main Road, Panruti Taluk, Cuddalore District, Tamilnadu-607103 was granted recognition for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.TN/SEC/SRO/NCTE/2005-2006/3767 dt. 02.11.2005.

AND WHEREAS, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 24.08.2010.

AND WHEREAS, After the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 28.01.2015, and the provisional revised recognition order was issued on dt. 13.05.2015 to the institution for conducting **B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units** from the academic session 2015-2016.

AND WHEREAS, the institution submitted compliance against RPRO matter on dt. 29.07.2015 for both courses B.Ed.

AND WHEREAS, the SRC in its 315th Meeting held on 17th to 18th June 2016 considered the matter and decided as under: -

1. They have shifted B.Ed. without NCTE approval.
2. Title deed is in order. Land area is adequate.
3. LUC and EC are in order.
4. BP is in order. BCC is in order. Built up area is adequate for B.Ed. (2 units) and M.Ed. (1 unit).
5. Inspection fee not paid.
6. Original FDRs not given.
7. Latest Faculty list not given.
8. Collect fee and cause composite inspection.
9. Ask VT to collect all relevant documents.

AND WHEREAS, as per the decision of SRC, Inspection intimation was sent to the institution through on-line VT module. VT members names were generated through on-line VT module. Visiting Team report was received on 18.10.2016.

AND WHEREAS, the VT report was placed before SRC in its 340th meeting held on 08th to 09th June 2017, and the Committee decided as under; -

1. Title is clear. Land area is adequate.
2. LUC & EC are in order.
3. BP & BCC are in order. Built up area (2980 sq. mts.) is adequate for B.Ed. (2 units) + M.Ed. (1 unit) (1500 sq. mts combo + 500 sq. mts.).

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on dt. 16.06.2017 for M.Ed. course.

AND WHEREAS, the institution has submitted its reply against Show Cause Reply on dt.19.07.2017.

AND WHEREAS, on the basis of decision taken by the SRC in its 369th meeting held on 28.01.2019.

AND WHEREAS, for non-submission of Show Cause Notice reply the matter was placed before the SRC in its 387th Meeting held on 24th & 25th August 2020 wherein the Committee decided to issue Final Show Cause Notice. Accordingly, as per the Committee decision a Final Show Cause Notice was issued to the institute vide letter dt. 01.09.2020.

AND WHEREAS, a reply was received from the institution on dt. 21.09.2020 along with the desired documents.

AND WHEREAS, the compliance submitted by the institution on dt. 21.09.2020 and the matter was considered by the SRC in its 390th Meeting held on 28th & 29th October 2020 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

16. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

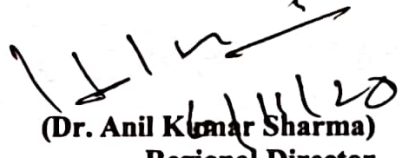
